## Book 2, Page 117, Wills, Newton County, Georgia.

In the Name of God Amen. I, Henry Talley of the State of Georgia and County of Newton, being of sound mind and memory do make and ordain this my last will and testament in manner and form following to-wit. First I give and bequeath unto my wife Eadeth Talley one negro man named Stephen one useing creture and side saddle and bridle one bed and furniture two cows and calfs together with all my house hold and kitchen furniture. I also loan unto my wife one cart and yoak of oxen and all my farming tools also one negro named Clayburn also two cows and calfs, six head of choice sheep out of my stock of sheep, also the lot of land whereon I now live, also the balance of my horces with the exception of one filly which I give to my son, William Talley, known as Wms. Filley, also I loan to my wife all my stock of hogs.

The above loan to expire at the death or Intermarriage of my wife, or when my youngest son, George W. Talley arrives at the age of twenty one years at which time all of the above loned property with the exception of the land is to be sold and the proseeds Equally divided between my children now living with me to-wit, William, Nathan, George W. and Elizabeth, to be so arranged as to make Nathan, Elizabeth and George W. up even with the amount of the above filley given to William before he shall come in for an equal part, and after they are made equal then the balance to be divided between the above named Four children, the price of the filley to be governed by the appraisment.

Secondly I give unto my son William one hundred one and one fourth Acres of land being the north half of lot number four hundred and eighteen and in the sixteenth Dist. of formally Henry, now Newton County.

I also give to my son Nathan all that tract or lot of land known as number four hundred and thirty two in the sixteenth Dist. formally Henry, now Newton County. I also give unto my daughter Elizabeth one negro boy by the name of Samson. I also will that certain tract of land cituate in the tenth dist. of formaly Henry now Newton County known in the plan of said dist. by number one hundred and forty two be sold when my son George W. arrives unto twenty one years og age and the proseeds be equally divided between my sons William, Nathan, George W. and my daughter Elizabeth.

I also give to my son Henry H. Talley two notes of hand principal amount two hundred and eight dollars and fifteen cents which I hold on him. I also give unto my son-in-law Francis McWaters one note of hand for two hundred and seventy five dollars which I hold on him. I also give my daughter Lucty McWaters five dollars to be paid at the division of my property.

I also give to my daughter Sarah Clark and her bodyly airs one negro girl named Charrity which she has allready in possession I also give unto my daughter Sarah Clark five dollars to be paid at the division of my property.

I also give to my daughter Eliza Hinton, one negro gril named Judy also five dollars in money to be paid at the division of my property.

I also give unto my daughter Mariah Farmer one negro boy named Wilson, one side saddle and bridle and five dollars in money to be paid at the division of my property.

I also will that my joiners and carpentry tools and all my stock not given



away be sold at my death and the proseeds be Equally dividual tratmeen my sons William, Nathan, George W. and my daughter Elizabeth.

I also appoint Jesse L. Baker sole Executor of this my last will and testament, hereby Revoking all former wills by me made.

Signed, sealed and acknowledged by the said Henry Talley to be his last will and testament this nineteenth day of April in the year of the Lord one thousand eight Hundred and thirty one and the fifty fifty fifty fifty the Independence of the United States of America.
