Whereas my late husband George Sackville Cotter, deceased, by his last will and testament amongst other things devised my share or interest in the property in Ireland as he the said George Sackville Cotter was authorised and empowered to do under and the virtue of the terms and conditions of the Marriage Settlement between the said George Sackville Cotter and myself and which said property is known as Springfort O'Kellars as mentioned in the said will to my four children, Matilda Louisa Johnson, wife of Henry T. Johnson of the village of Dunnville, Merchant; George Sackville Cotter of the town of Cayuga in the said county of Haldimand, Deputy Registrar of the county of Haldimand; William Crofts Cotter of the said township of Dunn, Gentleman, and James R. Cotter of the town of Barrie, Barrister-at-law and I hereby confirm the said will and if there is any doubt as to the ability of the late George Sackville Cotter to will and devise the said property, I hereby will and devise and bequeath the same equally among the four said children to have and to hold unto their heirs and assigns for ever.

The sum of \$ 200, now in the hands of my said daughter Kate Docker I dispose of as follows

I bequeath to the said Kate Docker the sum of \$50.

I bequeath to the said Minnie Orris the sum of \$50.

I bequeath to my granddaughter Louisa Orris the sum of \$50.

I bequeath to my granddaughter Hallie Johnson the sum of \$50.

the said legacies to be paid by my executrix hereafter named as soon after my decease as possible.

Whatever money I have in the Court of Chancery or whatever claim I may have to the Scott Freeman Estate, I bequeath equally to my two sons the said George Sackville Cotter and William Cotter.

I hereby bequeath unto to my daughter the said Matilda Louisa Johnson the sum of £ 200 sterling money of Great Britain or the proceeds thereof which has been bequeathed to me by my late sister the said Mrs Ann Baldwin, late of Mallow in Ireland, widow, to have and to hold the same unto to the said Matilda Louisa Johnson for ever.

And I hereby nominate, constitute and appoint as executrix of my last will and testament the said Matilda Louise Johnson.
